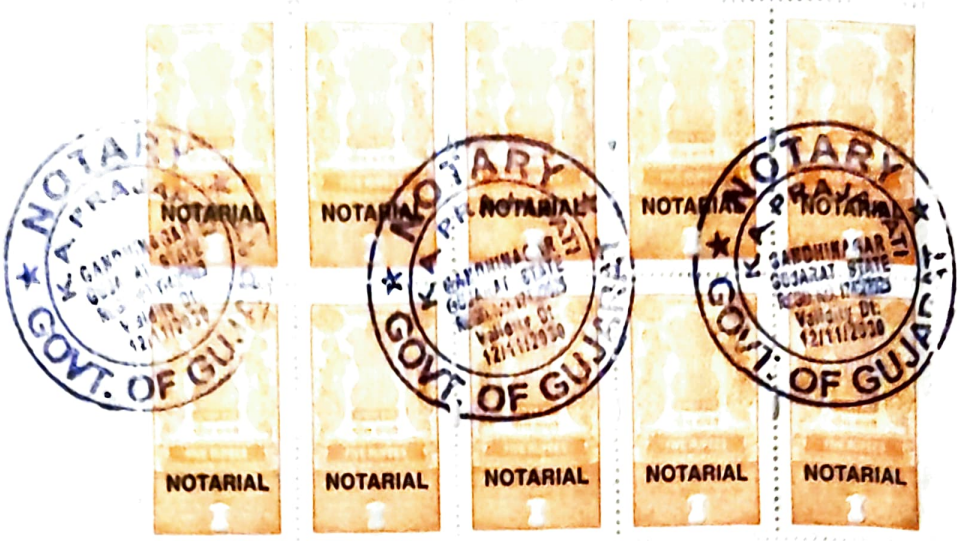

MEMORANDUM OF UNDERSTANDING (MOU)

21 MAR 2026
21 March 2026

This Memorandum of Understanding (MoU) is made and entered into on this 21 day of March 2026,

BETWEEN

Goenka Ayurveda Hospital, attached with Manjushree Research Institute of Ayurvedic Science, having its registered office at Piplaj, Pethapur Mahudi Road, Gandhinagar, hereinafter referred to as "First Party / Hospital",

AND

Amambod Panch
(Ambod) Gram Panchayat, Ambod Village, Taluka Mansu, District Gandhinagar, represented through its Sarpanch/Authorized Representative, hereinafter referred to as "Second Party / Gram Panchayat". The First Party and Second Party are hereinafter collectively referred to as "the Parties".

1. PURPOSE OF THE MoU

The purpose of this MoU is to establish a cooperative framework between Goenka Ayurveda Hospital and Ambod Gram Panchayat for opening and running an Ayurveda Out-Patient Department (OPD) at Ambod Village, with the objective of providing affordable, accessible, and quality Ayurvedic healthcare services to the local population.

2. SCOPE OF SERVICES

The Ayurveda OPD at Ambod Village shall include

- General Ayurvedic consultation Diagnosis and treatment as per Ayurvedic principles Preventive and promotive healthcare guidance.
- Distribution/prescription of Ayurvedic medicines as per norms Health awareness and wellness programs (as feasible).

3. RESPONSIBILITIES OF GOENKA AYURVEDA HOSPITAL

Goenka Ayurveda Hospital agrees to:

- Depute qualified Ayurvedic doctors and/or paramedical staff for OPD services as per mutually decided schedule.
- Provide professional consultation and treatment following standard Ayurvedic practices and ethical norms.
- Arrange essential OPD equipment and basic medical instruments required for consultation. Prescribe or supply Ayurvedic medicines as per availability and applicable regulations.
- Maintain proper OPD records of patients, treatments, and services rendered. Ensure compliance with all applicable laws, rules, and guidelines related to medical practice.

4. RESPONSIBILITIES OF AMBOD GRAM PANCHAYAT

Ambod Gram Panchayat agrees to:

- Provide suitable space/room for running the Ayurveda OPD at Ambod Village, free of charge
- Ensure basic infrastructure such as seating arrangement, electricity, water supply, and cleanliness.
- Assist in informing villagers about OPD services through local announcements or notices.
- Extend necessary local administrative support for smooth functioning of the OPD.

5. OPD TIMINGS AND DAYS

The OPD days and timings shall be mutually decided by both Parties and may be revised from time to time based on local requirements and feasibility

6. FINANCIAL ARRANGEMENT

This MoU is entered into on a non-commercial and service-oriented basis, unless otherwise mutually agreed in writing. Any consultation fees, if applicable, shall be decided jointly and informed to the public in advance. Each Party shall bear its own expenses unless specifically agreed otherwise.

7. DURATION OF MoU

This MoU shall be valid for a period of __ years, effective from the date of signing, and may be extended further by mutual written consent of both Parties.

8. TERMINATION

Either Party may terminate this MoU by giving 30 days' prior written notice to the other Party. In case of termination, OPD services shall be discontinued in an orderly manner without affecting ongoing patient care, as far as possible.

9. CONFIDENTIALITY

Both Parties agree to maintain the confidentiality of patient records and any sensitive information exchanged during the course of this MoU.

10. DISPUTE RESOLUTION

Any dispute arising out of or in connection with this MoU shall be resolved amicably through mutual discussion. If unresolved, the matter shall be subject to the jurisdiction of local courts only.

11. AMENDMENTS

Any modification or amendment to this MoU shall be made only by mutual written consent of both Parties.

12. NON-LEGAL BINDING CLAUSE

This MoU reflects the mutual understanding and goodwill of the Parties and does not create any legal partnership or employer-employee relationship.

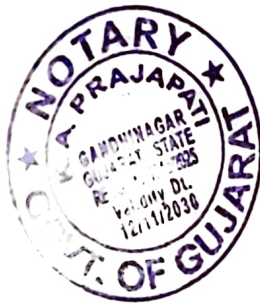
